Featured Article: How to Choose the Right Professional Advisor

Many donors that begin giving through CLF each year learn about us because of a referral from their professional advisors – financial advisors, CPAs, attorneys, and others. Odds are, you've already chosen your advisor, but those who haven't often wonder, what does the "right" one look like? What are some of the characteristics you should be looking for as you select an advisor?

Consider the following factors as you go through this selection process:

Is he or she technically competent?

In any area of life, we all want to work with someone who knows what they are doing. It's not enough to know that someone is a Christian. Do they have experience and expertise in their field? Are they someone you can trust with your situation?

Is their worldview compatible or consistent with my own?

Finding an advisor with a Biblical Worldview is a must for any Christian. Because we are merely "stewards" – as opposed to "owners" – of the gifts, abilities, and assets that have been entrusted to us, those we seek counsel from should hold the same worldview we do. If not, there will inevitably be conflict.

The Charitable Gift Annuity: A way to support ministries and receive income for life

Do you want to make a gift to one or multiple charities? Would you like to receive regular, fixed income for the rest of your life? Would you like income to go to your spouse, parents, children, or a friend? Do you want to remove assets from your taxable estate? Are your CDs and money market returns lower than you would like?
